WHAT MATERIALS WERE USED TO BUILD OCEAN EXPLORERS?

TO BUILD THIS EVENT WE HAVE CHOSEN SUSTAINABLE MATERIALS WHERE POSSIBLE. WHERE WE WERE UNABLE TO US SUSTAINABLE MATERIALS, WE WILL EITHER RECYCLE THE ITEM OR DONATE THE ITEM/S.

PLEDGE POOL

- The floor: Ply construction sub floor with eco-friendly anti-slip printed floor vinyl. The vinyl used is collected by the manufacturer post use and recycled. The supplier credentials include, zero waste to landfill programme at Lancaster, reduced energy consumption, smaller carbon footprint than their competitors.
- Screen surround & button plinths: Made from Ply
- The structure: aluminium frame and natural 3 strand cotton rope for decoration.
- The Pool: Ply construction, BPA Free ball pit balls which are hired, wooden props.
- The Pool: Acrylic bins in natural colour so can easily be reused, bean bags to be reused for future event and MetaSteam environmentally friendly vinyl.
- The LED words: These are going to be donated to WWF and Greenpeace for future use

The plywood used for this is event is sourced from Garnica, a leader and a driving force for change in the transition from importing tropical timber to using sustainable, local raw materials. https://www.garnica.one/en-uk/sustainability.html

THE TURTLE

• The bottles: All bottles used in this structure have been collected from our two Westfield centres, recycled by our customers. After this event, the bottles will return to the recycling process.

JOLLY JELLYFISH

- The floor: Ply construction sub floor with eco-friendly anti-slip printed floor vinyl. The vinyl used is collected by the manufacturer post use and recycled. The supplier credentials include, zero waste to landfill programme at Lancaster, reduced energy consumption, smaller carbon footprint than their competitors.
- The Jellyfish body: Made from SmartX which is collected and 95% recycled by the manufacturer
- The Frame: Aluminium frame which will be recycled locally
- The Tentacles: Pool noodles which will be donated to a local swimming pool post event, the lights have been reused from a previous Westfield event. Fabric socks have been made for the steel legs to replace the use of PVC coverings.

CORAL COVE

- Table: Recyclable plywood top with Frost Perspex topper. The Perspex acrylic is made from 100% recycled rMMA, obtained from material scraps and waste. Post event this is returned to the manufacturer to be recycled. The manufacture ensures that zero acrylic waste from its' sheet production sites goes into landfill. All acrylic waste is recovered and returned back into the production process.
- Chairs: recyclable Metal stacking stool with plywood top
- The materials for activities: The single use plastic items being used in the crafts have been recycled by our local community: Alfred Salter Primary School, St Michael's Catholic College, AMM LTD, Telford Homes, Chrisp Street Centre, Sunny Jar Eco Hub 'Plastic Free Poplar' Community Litter Picks

DOLPHIN DIVING

• Trampolines: These trampolines have been reused from our 2022 summer event. We've improved the design of the vinyl covering, meaning we only need to replace minimal sections of vinyl for our second event. Eco-Friendly vinyl has been used for this platform. These trampolines are going to be stored again for future use.

GENERAL EVENT SPACE

- The flooring: This event has been designed to negate the need for a sub floor. The floor vinyl is PVC free PET (Polyethylene Terephthalate) and made from 40% industrial recycled content making it one of the most environmentally friendly short term floor graphics materials available. The waste product will be incinerated for RDF (Refuse derived fuel).
- The Coral: Steel base plates & rods (recyclable locally) with Plywood tops
- The signage posts: Steel base plates & rods (recyclable locally) with Plywood tops with eco-friendly vinyl
- The Entrance Arches: Timber frame (recyclable) with layers of Frost Perspex. The Perspex acrylic is made from 100% recycled rMMA, obtained from material scraps and waste. Post event this is returned to the manufacturer to be recycled. The manufacture ensures that zero acrylic waste from its' sheet production sites goes into landfill. All acrylic waste is recovered and returned back into the production process.
- This entire event is moving to Westfield Stratford City mid-August for a 10-day event there, meaning the set has a second life.
- Stickers: 100% compostable stickers composed of 95% of sugar cane fibres and 5% of hemp and linen.
